



2025 - 2026 Vitality Dance Company Auditions

VDC is a dance company for experienced dancers ages 9 and up. Our mission is to create an elite group of dancers that value not only community involvement through performance and volunteer work, but also through expanding their knowledge and appreciation of the arts. We want to open these dancers to the world of dance outside our studio doors and let them experience classes with master teachers as well as a chance to compete with their team.

VDC Audition Requirements:

- Must be 9 years of age or older as of Jan. 2026
- Must take 15 hours of Summer Punch Card Classes and Ballet Intensive
- \$30 Audition Fee & VDC Application due at the time of audition
- **Audition Date(s): Friday, August 1st - Saturday, August 2nd**
 - Dancers will need to register for the **VDC Audition Class** through their customer portal or online at www.padbuda.com.
 - Registration closes on **Friday, July 18th**
 - Once all registrations are in you will receive an email with your dancer's audition times and number/letter.
- 2025 - 2026 VDC Company Members will be announced within 24 hours.
 - Mandatory Company Meeting - TBD

Expectations of our Company Members:

Conventions/ Competitions

- VDC will have the opportunity to attend multiple dance conventions throughout the year. Some of the conventions will have competition opportunities for solos, duets, trios and small groups.
- VDC Company members will attend THREE to FOUR dance competitions/conventions as a team. We will also have optional competition/convention options for solos, duets, trios etc. We are lucky to live in a city where the arts are highly valued and received.

VDC Collective - What is it?

A new program for dedicated younger dancers (4th - 6th grade) ready to push their training to the next level. To be eligible for the VDC Collective, dancers must also be a member of Vitality Dance Company.

What to Expect:

- VDC Collective dancers will take a weekly technique/choreography class
- VDC Collective dancers will compete an additional competition routine
- VDC Collective dancers will attend a required Spring Convention

How to Audition:

- Dancers will need to check the box on the audition form indicating they would like to be considered for Collective

Class Requirements

- Must take 3 classes at PAD during the 2025 - 2026 School Year. One of which MUST be Ballet.
- Members can only compete in a genre they take class in. (EX: Must take Contemporary to compete in a Contemporary routine. Must take Tap to compete in a Tap routine)

Rehearsal Requirements

- Company rehearsals are held on Sunday afternoons with a possibility of occasional Saturday rehearsals if needed.
- Company members will rehearse THREE to FOUR times a month.
- Company members will receive a schedule two months at a time to allow for planning etc.
- VDC company members must notify the director/instructor of any absences for company rehearsals by email. **Absences need to be kept to a minimum** as the director has the right to remove any dancer after 3 missed rehearsals.

Solo, Duet and Trio Requirements (OPTIONAL)

- All solos, duets and trios must be approved by the director.
- Rates for solos, duets and trios are determined by the choreographer.
- Must schedule TWO half hour or more rehearsal sessions per month
 - No instructor required
 - Studio Usage Fees will apply and be charged automatically each month, October - April.

Uniform & Required VDC Attire

- VDC Backpack - \$50 - \$100
- VDC Jacket - \$75 - \$85
- VDC Team Shirt - \$25
- Rehearsal attire: Proper dance attire. No Running Shorts!
 - Leotard (any color), Hot Shorts, Leggings
 - Hair pulled back

VDC Company Fees and Tuition

- Company members - **\$75 VDC Tuition per month** (3 - 4 rehearsals per month)
- Costume Fees - **\$80 - \$85 per routine**
- Competition Fees - **\$75 - \$85 per routine** depending on competition
- Competition Media Packages - **\$30 - \$50 per competition**
- Guest Choreography Fees - PAD will pay a portion of the choreography fee and the remaining amount must be paid by the dancers participating in that particular routine.
